The impact of COVID-19 is still evident, particularly in California, where shelters are overwhelmed with dogs, resulting in thousands being euthanized. As an independent nonprofit, we are inundated with requests for assistance in providing care and access to medical services to those who cannot afford it. We have successfully more than doubled the number of dogs rescued this year, increasing from 400 to over 1,000. However, this significant increase in our rescue efforts has come at a cost. To enhance our operations, we have begun implementing accounting software, which will enable us to manage our finances more effectively and ensure timely filings in the coming year.
